



With reference to the above, this is to inform you that the above mentioned Tender Enquiry is hereby amended as below:



Completely Closed metal body container trucks (Specification -1A) :-</p> <p>(a) The vehicle (any make) provided should not be more than Five years old as on the date of each consignment and fit for movement on highway at high speed (about 70kmph with full load). The truck should be roadworthy. Inside floor of the Trucks should be of metal plate.</p> <p>(d) The vehicle dimensions should be approx. 10 ft x 8 ft x 18 ft (Height x Width x Length).</p>	 <p><i>Should be read as</i></p>	<p>1. The truck should be roadworthy.</p>
