PUBLIC PROCUREMENT POLICY FOR MICRO AND SMALL ENTERPRISES (MSE's)

As per Public Procurement policy (PPP) for Micro & Small Enterprises (MSEs) Order, 2012 issued vide Gazette Notification issued in March 2012 by Ministry of Micro, Small and Medium Enterprises of Govt. of India and subsequent Micro and Small Enterprises (MSEs) Amendment Order, 2018 Amendment order, 2018 dated 09.11.2018, MSEs must be registered in order to avail the benefits / preference available vide Public Procurement Policy MSEs Order, 2012.

I. Relaxation for Micro and Small Enterprises(MSE): Relaxation for MSE regarding submitting Tender fees, Earnest Money Deposit, prior experience, prior Turnover Criteria issued by Govt. of India, Ministry of Micro, Small & medium Enterprises, New Delhi and further amendments, if any subject to the certificate provided should valid till tender validity period as per the following references-

- a) Policy Circular No.1(2)(1) 2016-MA dated 10.03.2016 of Additional Secretary and Development Commissioner-MSME, GOI, New Delhi.
- b) O.M.No. F.20/2/2014-PPD (Pt.) dated 25.07.2016 of Under Secretary to GOI, MOF, Department of Expenditure Procurement Policy Division, New Delhi.
- c) O.M.No. F.20/2/2014-PPD (Pt.) dated 20.09.2016 of Under Secretary (PPD) to GOI, MOF, Department of Expenditure Procurement Policy Division, New Delhi.
- d) Price Preference to MSE is applicable to this tender vide Ministry of Micro Small and Medium Enterprises letter no. D.O.21(1)/2011-MA dt.25/04/2012.

Purchase Preference:

- i) Issue of tender document to MSEs free of cost
- ii) Exemption to MSE's from payment of EMD
- iii) In case MSE bidder is L1 entire value of the tender is to be ordered on the L1 MSE bidder.
- iv) In tender, participating micro and small enterprise quoting price within price band of L1+15% shall also be allowed to supply a portion of requirement by bringing down their prices to L1 price in a situation where L1 price is from someone other than a micro and small enterprise and such micro and small enterprise shall be allowed to supply up to 25% of the total tendered value. In case of more than one such micro and small enterprise, the supply shall be shared proportionally (to tendered quantity). Further, out of above 25%, 5% (20% of 25%) shall be reserved for MSES owned by SC/ST entrepreneurs. Further, 3% shall be reserved for MSES owned by women within above 25% reservation. The respective quota(s) shall be transferred to other MSES in case of non-availability of MSES owned by SC/ST entrepreneurs/MSES owned by women.
- v) In case of more than one such MSEs are in the price band of L1 + 15% and matches the L1 price, the supply may be shared proportionately if the job can be split.
- vi) In case tendered item is non-split able or non- dividable (specified in Bid Data Sheet/Bill of Quantity/Price schedule), MSE quoting price within price band L1 (other than MSE) + 15%, may be awarded for full/ complete supply of total tendered value subject to matching of L1 price.
- vii) If the quantity cannot be split and there are more than one eligible MSE bidders (price band within L1+15%) then the opportunity to match the L1 rate of the tender shall be given first to MSE (who have quoted lowest rate among the MSEs within the price band of L1+15%) and the total quantity shall be awarded to him after matching the L1 price of the tender.
- viii) If the MSE who have quoted lowest rate among the MSEs in the price band of L1 + 15% do not agree to match the rate of L1 of the tender, then the next ranked MSE bidder who has quoted within the price band of L1 + 15% in order shall be given chance to match the rate of L1 for award of the quantity/order and so on.
- ix) In case, none of the MSE's in the price band L1+15% agree to match the L1 price, then the contract shall be awarded to the original L1 bidder.
- x) For more clarity in this regard, following table is furnished.

II. Conditions for availing relaxations under MSEs:

- MSEs participating in the tender must submit valid & authorized copy of certificate of registration. In case of bidders submitting DIC registration certificate shall attach original notarised copy of the DIC certificate.
- Traders/ resellers/distributors/authorized agents will not be considered for availing benefits under PP Policy 2012 for MSEs as per MSE guidelines issued by Ministry of MSME.
- The registration certificate must be valid till tender validity period. Bidder shall ensure validity of registration certificate in case the tender opening date extended.
- The MSEs who have applied for registration or renewal of registration with any of the agencies/bodies, but have not obtained the valid certificate as on tender opening date, are not eligible for exemption/preference.
- The MSE's Bidder to note and ensure that nature of services and goods / items manufactured mentioned in MSEs certificate matches with the nature of the services and goods/items to be supplied as per Tender for availing relaxation.

III. As per Office Memorandum No. F.20/2/2014-PPD (Pt.) dated 20.09.2016 issued by MOF, Department of Expenditure, Procurement Policy Division, New Delhi.

- Pre-qualification criteria with respect to Prior Turnover and Prior experience may be relaxed for Micro & Small Enterprises as per GOI guidelines subject to meeting of quality and technical specifications.
- However, there may be circumstances like procurement of items/services related to public safety, health, critical security operations and equipment, etc. wherein, BRBNMPL reserves the right not to consider relaxation of Prior Turnover and Prior Experience for Micro and Small Enterprises as per GOI guidelines.
- MSE's/Start-up companies participating in the tender must submit declaration & undertaking on the Company/Firm's letter head as per the format specified in the tender/corrigendum.

IV. Conditions for availing relaxations for start-ups in public procurement (Preference to Make in India):

Purchase preferences to start ups as per make in India policy is applicable to this tender as mentioned in the circular issued by Ministry of Commerce and Industry, Department of Industrial Policy and Promotion (Public procurement Section) vide P-45021/2/2017-PP (BE-II) dated: 28th May, 2018, order no. 2017 (Revised) and any subsequent revisions, if any.

CONDITIONS FOR START-UP COMPANIES

- Subject to meeting of Technical specifications, BRBNMPL may consider allowing the participation of "Start-up" companies with capability to execute the supply/ services, as per technical specifications/ perform the job as per scope of work specified in the tender and subject to meeting extant & relevant guidelines of Government of India. This should be confirmed and substantiated in the technical bid.
- The bidder who intends to participate as "Start-up" company should enclose the Certificate of Recognition issued by Department of Industrial Policy and Promotion, Ministry of Commerce & Industry, Govt. of India during submission of Technical bid.

- c) Prequalification Criteria with respect to Prior Turnover and Prior Experience may be relaxed for Start-ups as per the GOI guidelines.
- d) However, there may be circumstances like procurement of items/services related to public safety, health, critical security operations and equipment, etc wherein BRBNMPL reserves the right to not consider relaxation of Prior Turnover and Prior Experience for Start-up Companies as per GOI guidelines.
- e) Start-up Companies who are also registered as MSEs and wish to avail the benefits as applicable to MSE, shall submit relevant documents covered under Conditions for Micro and Small Enterprises elsewhere in this tender.
- f) Verification of Local content: The local supplier shall be required to provide a certificate along with the tender document from the statutory auditor or cost auditor of the Company (in the case of companies) or from a practicing cost accountant or practicing Chartered accountant (in respect of suppliers other than companies) giving the percentage of local content.
