Supply, Installation, Testing and Commissioning of Lighting System for 30 Mtr. High Mast.

A. SCOPE OF WORK: -

- 1. Contactor shall tap power supply for 30 meter high mast tower from the nearby Feeder Pillar No 19.
- 2. Erection and commissioning of High mast tower of 30 meter height includes material and labour. Location of High Mast Tower is behind the A-Type Quarters of Township, BRBNMPL, Mysuru.
- 3. Installation of lighting luminaries with all the accessories and related works as per standards
- 4. Contractor shall lay the Cable as per the route directed by BRBNMPL and standard practice shall be followed for termination of cables.
- 5. Contractor shall do the necessary arrangement for identification of cable by providing the proper cable tag and also mark incoming and outgoing legends suitably on the feeder. 3. **HIGH MAST**

3.1 Structure
