The Payment against uniform, shoes & bonus will be released on succeeding month on submission of documentary evidence. The contractor should pay the Bonus payment as per the provision of payment of Bonus Act, 1965 to their labourers.
- viii) The tender will be decided on the overall lowest L1 basis and after considering purchase preference policy for MSE's as mentioned at Section-III of this tender and then Contract will be awarded accordingly.
