i) Closed Metallic Containerised Trucks having below mentioned features / requirements:

a) Height – 10 feet (Maximum), Width – 08 feet, Total Length – Length of Container + Length of the (Driver + Passenger) Cabin – not more than 28 feet., with twin door rear lockable opening.

#### C. Other Requirements :

- Each fully closed metallic Containerised trucks should be brand new and road-worthy. They should have metallic body of sufficient thickness, preferably bullet / tamper proof with secure tamper proof double locking facility (traditional, i.e. lock and key and biometric amenability) and have tubeless tyres.
- ii) The base/surface on which the Security Material will be loaded should be plain & without dents/obstruction/holes/breakage for easy loading / unloading of the consignment.
