I. Introduction:

Bharatiya Reserve Bank Note Mudran Private Limited (BRBNMPL) is a wholly owned subsidiary of Reserve Bank of India having two printing presses in India, one at Mysuru and the other at Salboni for printing of bank notes.

II. Preamble:

As an effort towards finding alternative substrate(s) for printing of Indian bank notes to increase their life expectancy, BRBNMPL intends to collect technical and commercial information from resourceful and capable vendors having experience in manufacturing and supply of Plastic based substrates. This exercise is meant purely for collection of information, samples for testing purposes, identification of potential suppliers and market exploration.

III. Our Requirement:

We require 100 pieces each of varnished and unvarnished dummy offset preprinted bank notes, not being legal tender in any country, on the following types of Plastic based substrate suitable for banknote printing:

- a) Pure Polymer
- b) Two layers of polymer on surface with paper in between
- c) Two layers of paper on surface with polymer in between
- d) Any other material or combination of materials

A respondent may, if so desired, submit samples of offset printed dummy notes on more than one type of substrate. However, in such cases, the technical details as per part II of the Annexure shall be submitted separately in respect of each type of substrate.

The samples supplied in response to this invitation shall be prominently marked "Sample, not a legal tender" across the body of each piece supplied and be supplied on non-returnable basis. Unused samples shall become the property of BRBNMPL for subsequent use for testing and research purposes only or be destroyed, as deemed fit by BRBNMPL. The respondent shall have no right to information, prior intimation and/ or presence in this regard.



IV. Availability of Document:

This invitation document may be downloaded from the BRBNMPL website: www.brbnmpl.co.in or be obtained from BRBNMPL, Bengaluru at the address mentioned above free of cost.

V. <u>Invitation Document and Processing fee</u>:

No fee is applicable, as the intention of this exercise is collection of information and samples, identification of potential suppliers and market exploration.

VI. Respondents' Conference:

BRBNMPL, if it so desires and at its sole discretion, may arrange for respondents' conference or request the respondents to give detailed presentation about their product.

VII. How to respond:

Interested vendors having experience in manufacturing and supply of Plastic based bank note substrate shall ensure that the Invitation document (Annexure) duly filled, sealed and signed in all pages, complete in all respects as per instructions contained along with the invoice, are sent through post or dropped in the tender box located at the address specified on or before the closing date and time indicated in the Para VIII. The document along with necessary supporting documents should be placed in a sealed cover and clearly superscribed as "Global invitation for supply of samples of dummy offset pre-printed notes on Plastic based substrate suitable for Indian banknotes".

VIII. <u>Timeline for submission of Document</u>:

Duly filled in documents along with the samples should reach our office on or before 1100 hrs on 31st July, 2019. In the event of this date being declared as a holiday/ closed day for BRBNMPL, the samples will be received till the next working day at the appointed time. However, since this is only an exercise for collection of information and samples, identification of potential suppliers and market exploration and not a pre-qualification bid notice, tender or request for proposal, BRBNMP may, at its sole discretion, entertain samples received even after the deadline (or the extended deadline, as the case may be) by issuing an addendum to be made available on the BRBNMPL's website. No respondent shall have the right to protest BRBNMPL's decision in this regard.
