 - x) Each fully closed vehicle should be fitted with GPS tracking system which can be monitored live with geo-fencing mapping.
 - xi) GPS tracking system should be such that it can be tracked by the Bank / the BRBNMPL/ the law enforcement agencies / the Contractor (if authorised by BRBNMPL) at any time with the additional indication of the nearest police stations in the corridor for emergency.

C. Other Requirements:

- i) Each trucks/ containers offered should be road worthy and not more than 3 (Three) year old. The vehicles should be in absolute fit working condition.
