- 1) **Pre-Bid Visit:** The bidders are advised to visit the premises to have understanding about scope of work; volume of work, any doubt/clarification may be cleared before submitting their offers. Any claim of ignorance about the system or responsibility shall not be entertained in later stage.
- 2) **Time schedule:** Work shall be completed within 30 days from the date of Issue of work order. The total time period as specified above for the completion of the job is to be strictly maintained and is the essence of the order.
- 3) **Payment**: 90% of total ordered value shall be paid after successful completion of work against FAC (Final Acceptance Certificate) issued by BRBNMPL, and remaining 10% value will be withheld against Security Deposit (including EMD amount) and the same will be released on subject to submission of equal value of Bank Guarantee as per GCC clause 6. The security deposit will be returned after completion of warranty period of 12 months from the date of issue of completion certificate without interest.
- 4) Security Deposit: As per clause 6 of General Condition of Contract (GCC).
- 5) **Compensation for delay:** For any delay beyond the time specified above without any valid reason, liquidated damages @ 0.5% of the value of the work shall be levied per week of delay, subject to a maximum of 10% of total value of works completed / final bill value. Quantum of liquidated damages assessed and levied by BRBNMPL shall be final and not challengeable by the supplier / contractor. Contractor has to apply for extension with valid reasons at least 10 days prior to the completion date.
- 6) **Statutory Deductions:** Statutory deductions such as WCT, VAT, Income Tax etc as applicable shall be effected while making payment.
- 7) BIDS submitted not in accordance with the above guidelines & with counter conditions will be liable for rejection. BRBNMPL will examine the materiality/Significance of the

The contractor shall be liable to replace/repair any defects within the warranty/defects liability period free of cost to the BRBNMPL.
- 11) **Recovery & Rectification of work:** In case contractor fails to attend the same as per defect liability period clause above within a week from the date of intimation, it shall be got rectified by the owner through another agency & money spent thus shall be recovered from the contractor. If the work is not completed in all respect or delayed beyond reasonable time or contractor discontinues the work abruptly, then BRBNMPL reserves right to get the remaining work / uncompleted work done through any other agencies at the risk and cost of the contractor. In such case, the pending claims and security deposit of the contractor shall be forfeited.

12) Safety & Security Measures:

- a) The contractor should scrupulously confirm to the safety and security norms as stipulated by BRBNMPL while working in the security area.
- b) The contractor shall take all the precaution while executing this work. Protective gear such as safety helmets, boots, belts etc. shall be provided by the contractor at his own cost to all his workers at site. The Contractor shall impose such requirements on all sub-contractors also. It shall be the responsibility of the contractor to ensure that such protective gear is worn at all times by all personnel working at site. BRBNMPL shall have the right to stop any person not wearing such protective gear from working on the site.
- c) BRBNMPL is a security organization and the Govt. of Karnataka declares the premise as Prohibited Area. Hence the contractor has to abide by the security rules of the Company. The contractor has to ensure the character and antecedent of the persons deployed. The contractor must be in a position to produce such documents whenever he is asked to do so. Details shall be furnished as per format when called for. The contractor has to issue printed photo identity card to its workers duly authenticated by the designated security officer of the Company. Contractor should apply for Gate Pass for labors, welding permission and material entry pass etc. as per approved format only, well in advance to avoid any delay in issue of Gate passes.
- d) On award of the contract the contractor shall sign the Non-disclosure format and abide with that.

- e) Any worker of the contractor, if found by the Company as unsuitable or having doubtful integrity, shall be removed from the premises at the risk and cost of the contractor. The contractor shall vouch guarantee for the integrity of its workers.
- 13) **Cleanliness: -** Contractor is required to ensure complete cleanliness at the site. Debris generated during the day's work should be disposed-off immediately.
- 14) **Electricity & Construction water:** Necessary source of electricity & water required for civil works will be taken from the available nearby source. In case the same is not available it should be arranged by the contractor.
- **15) Legal jurisdiction:** The court of Bangalore (Karnataka State) only shall have jurisdiction to deal with and decide any legal matter of dispute whatsoever arising out of any work order placed by us.

Section VII: Technical Specifications

1. PREAMBLE:

Bharatiya Reserve Bank Note Mudran (P) Limited (BRBNMPL) is a wholly owned Subsidiary of Reserve Bank of India is engaged in sovereign function of Design and printing of Bank Notes. It has corporate office at Bengaluru and has two printing presses at Mysuru, Karnataka and Salboni, West Bengal.

2. <u>SCOPE OF WORK</u>

- 1. Carefully dismantling of existing split air-conditioning indoor, outdoor units and it's connected copper piping and cabling etc. and store at a location outside of the office building and take away from BRBNMPL premises under buyback conditions after completion of the work.
- 2. Supply, installation testing and commissioning of Hi-wall split type air conditioning units at desired locations in consultation with companies Engineer having a nominal cooling capacity of 24000 Btu/hr (2 TR capacity) & a nominal cooling capacity of 18000 Btu/hr(1.5 TR capacity) having independent outdoor and indoor units with 3 split fan controls provided with energy efficient compressor, having nominal air flow of 620/560/500 CFM for 2 TR units and nominal air flow of 450/420/385 CFM for 1.5 TR capacity units in three different positions of high, medium and low control. The maximum noise level for the indoor unit shall not exceed 43dBA including cordless remote microprocessor control with battery to be operated on single phase 50 Hz 250 Volt +/- 10% . The indoor to outdoor connecting piping should be high quality copper only.
- 3. The tenderers are advised to enclose the catalogues giving details of various features, specifications and also dimensions of the indoor and outdoor units and their weights. The outdoor units housing shall be powdered coated and shall be mounted in the wall or floor with suitable mounting brackets which shall be painted with two coats of enamel paint after a coat of zinc cromet (antirust paint) as per the color approved by Bank. The water drain pipes must be neatly laid as advised by the Bank's engineer. The indoor units shall be provided with oscillating louvers having a sleep mode function in the programmed timer provided with electronic thermostat. The condenser shall have precoated copper blue fins to prevent from rusting and corrosion.
- 4. The rates quoted shall be inclusive of all taxes, duties, transport, packing, forwarding, insurance etc. and shall be for the complete work duly installed and commissioned at site. The prices quoted shall remain firm for the entire period of contract and shall not be subjected to any variations in the foreign exchange or variations of any other taxes, levies, duties etc. No import license will be furnished by BRBNMPL. The tenderers shall make their own arrangement for import of any part or components if any required for completion of the work.

- 5. The entire work of supply, installation, testing and commissioning of the Split ACs shall be completed within a period of 30 days from the 03rd day after the date of issue of the written order to commence work.
- 6. The equipment supplied such as Compressor unit, condenser unit and all other accessories individually and as a whole shall be guaranteed against all types of defects for a period of 1 year from the date of handing over of the equipment to BRBNMPL after successful completion of acceptance testing. Any defects in the system/sub-assemblies, found within the guarantee period/ AMC period shall be rectified/ replaced by the tenderer free of cost. In case of major repairs (any unit) Contractor has to arrange suitable/matching unit as a standby without any extra cost till original returns back at site. During this period, testing/servicing at quarterly interval or earlier, as prescribed by the manufacturer and as mutually agreed to, shall be carried out free of cost. Every visit details have to be furnished on Service report to be submitted to AM (T). Tenderer shall also indicate the service facility they can offer at the place of installation, the telephone number and address of their service centre.
- 7. The tenderers shall also quote their charges separately for all inclusive comprehensive maintenance service after the expiry of the one year defect liability period for consideration by the Bank and they shall continue to render comprehensive AMC for the next nine years. The total life span hence considered for the split ac unit is 10 years.
- 8. Any fault in the system shall be rectified within 24 hours of receipt of intimation of the defect in the system during the defect liability and service contract period. There will be a penalty of Rs.250/- per day, if the defect in the system is not rectified within the period of 24 hours as stated above informed over phone/Fax/Email/phone call.
