(BRBNMPL), a subsidiary of Reserve Bank of India, invites sealed quotations from eligible, bonafide and resourceful **India based Air Cargo Charter Service providers** for movement of precious cargo from Kolkata and Bengaluru to various destinations across India as per the terms and conditions mentioned below: -

1. Scope of work.

- Movement of precious cargo to be undertaken from Kolkata and Bengaluru to various destinations across India during the period from February to April 2017.
- Quotations are invited for Two Options as indicated in Price schedule of this tender document. Bidders can quote for one or both Options.
- BRBNMPL, at its discretion, may choose any one of the options or choose a combination of options based on our requirement for movement of precious cargo.
- Bidders will have to quote for minimum payloads of either 17.5MT or 31.25MT or both as per the aircraft payload capacity available with them.
- Whenever the charter services are utilized, the operator should ensure that the aircraft is exclusively reserved for us and no other cargo is permitted.
- Operator should be able to provide charter service within 24 hours' notice.
- If the operator has to arrange aircraft from outside India, he will be allowed max 72 hours for positioning the aircraft in India. Once the required permits are obtained, the operator should be able to provide charter service within 24 hours' notice.

2. General Terms and conditions

- Bidders will have to quote all-inclusive price (including handling, fuelling cost navigation cost etc.), but excluding service tax.
- Bidders will have to quote in Indian Rupees. Quotes in other currencies will be liable for rejection.
- The operator should be based in India and the aircraft/s operated should also preferably be registered in India.
- Payment will be made, in INR (Indian Rupee) after safe receipt of material at destination stations.
- Bids with counter conditions shall be liable for rejection.
- Bidders will have to quote in the prescribed format only.
- L1 will be determined for option 1 based on lowest price per block hour.
- L1 for Option 2 will be determined based on lowest overall price quoted for each category.
- Only those Operators who operate or can arrange aircrafts with min payload capacity of 17.5MT should quote for this tender. Operators who do not operate or cannot arrange aircraft with min payload of 17.5MT need not quote.
- For Option 2, operators who do not operate or cannot arrange aircrafts with min payload capacity of 31.25MT may also quote with more no. of trips (max no. of trips allowed is 2, to be completed within 24 hrs.). L1 will be determined based on overall price.
- Operators with higher capacity aircrafts may also quote for both payload options.
- Bidder can quote for one or both the minimum payloads in each Option.
- Tender can be rejected on national security grounds.
- BRBNMPL reserves the right to accept/reject/cancel any or all tender documents without assigning any reason thereof. BRBNMPL also reserves the right to accept the tender in whole or part.
- The quotation should be valid for at least 30 days.

- Sectors provided under option 2 is only indicative. BRBNMPL reserves the rights to place order for any other sectors, based on technical feasibility, on mutually agreed terms.
- If BRBNMPL choses to place order under Option 1, initial order will be for utilisation of 100 hours for the month of February 2017, which is extendable for the month of March 2017 and April 2017 for 100 hours of utilisation each month. If actual Block Hours utilized is more than order issued during the period, the hours in excess of the order will be paid at the price per Block Hour rate.

3. Standard Operating requirements

- All formalities for unloading from trucks, X-ray screening, palletizing and loading on to aircraft at source will have to be arranged by the cargo service provider.
- All formalities for unloading from aircraft, de-palletizing and transporting up to truck loading point at destination to be arranged by the cargo service provider.
- All required documentation, insurance, clearances and permissions for executing the delivery to be arranged by the cargo service provider at both source and destination.

Interested bidders may submit their sealed quotations at the address given above so as to reach us by 15:00 hours on 30th January 2017. Please note that quotations received after 15:00 hrs. on January 30, 2017 are liable to be treated as un-responsive and ignored.
