**SECTION – II : INTRODUCTION**

Bharatiya Reserved Bank Note Mudran Private Limited (BRBNMPL) is a wholly owned subsidiary of Reserved Bank India having two printing presses one at Salboni, West Bengal & the other at Mysore Karnataka and the Corporate Office at Bangalore, Karnataka, for banknote production. Other two banknote printing presses are operated by Security Printing & Minting Corporation India Ltd one at Dewas, MP and the other at Nashik, Maharashtra.

- i) This EOI is issued on behalf of Bharatiya Reserved Bank Note Mudran Private Limited (BRBNMPL), Salboni for supply of Calibrated Presspan Sheets to all four bank Note Printing Presses.
- ii) This Expression of Interest (EOI) is intended for finalisation specifications as per our requirements as mentioned in “**Section : III**”, identification of prospective vendor, evaluation of supplied Pre-production samples and budgetary estimation. Based on outcome of this EOI separate tender with appropriate specifications and qualification criteria will be floated for “Supply of Calibrated Presspan Sheets”.
- iii) Before submitting Expression of Interest, parties may obtain required clarifications/queries if any, from our Office at Note Mudran Nagar, Salboni – 721 132, West Bengal. For security reasons, the firm will be required to provide details of their representative/s who will be contacting/visiting BRBNMPL, Salboni. If found necessary, interested parties may visit with prior notice and permission to our Salboni press on any working day at their cost to understand the actual requirement.
- iv) The firms participating in the EOI, after their submission of offers, if required, will be called by BRBNMPL, Salboni for a detailed presentation and discussions regarding their offer of service/goods and the cost for such visits shall be borne by them.

**SECTION – III: REQUIREMENTS****A. Nomenclature of Product:** CALIBRATED PRESS PAN SHEETS**B. The product is also called:** Calibrated Press pan Boards/ Under-packing sheets/ Calibrated Underlay for Intaglio Printing/ Transformer Board**C. Brief Description of the Product:**

Calibrated Press-pan Sheets are used as under packing sheets for Intaglio printing machine impression cylinder blankets while printing bank notes / currency notes. Simply fitted in between the rough-top blanket and Impression cylinder, they enable precise control of the pressure for ink transfer by compensating for different thicknesses between the printing blanket and the printing plate. Under packing sheets having different thicknesses ensure the proper pressure. The accurate and uniform property of the Calibrated Press-pan Sheets as far as possible with regard to density, surface and thickness is important.

**D. Detailed specifications for Procurement:**

1. Must be suitable to use on Intaglio Printing Machine for Indian Bank note printing.
2. Must be made of cotton pulp, wood pulp or a mixture of cotton & wood pulp.
3. Manufacturer must mention the material details.
4. Press-pan sheets must have uniform thickness all over the surface and 100% calibrated.
5. Should have smooth calendared surface.
6. Press-pan sheets should withstand the temperature of 80° C and 80 ton /sq.cm pressure during printing.
7. Should be machine cut, precise in size and in Right angle (90°) at all the four corners.
8. The machine/grain direction of the sheets should be clearly marked on the backside of the sheets.
9. Surface should not peel off during continuous contact.
10. Colour- preferably brown.
11. In general, the life of press pan sheets should be at least 03 -05 machine shifts (9 hours/ shift) on Intaglio printing machine.
12. Shelf life of press pan sheets should be minimum 24 months from date of supply.
13. Accredited Laboratory test certificate of original manufacturer for the parameters mentioned should be submitted along with supply.
14. Should be properly wrapped in water resistant, shock resistant, air-cushioned package and sealed properly to avoid damages.
15. Bidder must mention the name of manufacturer and product brand name on each variety of samples.
16. Surface: Press-pan sheets should have wrinkle -free surfaces and also should be free from lint and dust.
17. Packing: Packing of material should be sturdy, able to sustain heavy pressure and water proof.

**Section IV: Qualification/ Eligibility Criteria**

The following are the Qualifying Criteria which must be fulfilled by the intending vendor:

1. Offers are invited from eligible and qualified Indian manufacturers or authorized representatives/dealers, distributors and stockiest of Indian manufacturers capable of manufacturing Calibrated Press pan Sheets used for banknote printing.
2. If representatives, dealers, distributors or stockiest are taking part in the EOI, the credentials of their principal manufacturer will be ascertained to meet the eligibility criteria.
3. Vendor's net worth of the firm should not be negative and also should not have eroded by more than 30% year-on-year in the last three years, ending on 31<sup>st</sup> March 2021.
4. The Bidder firm must have an annual capacity to manufacture or supply at least 30% of requirement of the item to which they are intending to participate. Please provide a statement confirming the above on your letter head.
5. The initial Pre-production lot of 12 no's of each variety of Press Pan Sheets to be supplied (Free of cost) along with EOI as "Pre-production samples/Pilot samples" for trial and acceptance by the respective presses.
6. **Annexure-G: Model Clauses for Tenders**

1. Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
2. "Bidder" (including the term 'tenderer', 'consultant' or 'service provider' in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process.
3. "Tender" will include other forms of procurement, except where the context requires otherwise.
4. "Bidder from a country which shares a land border with India" means: -
  - a. An entity incorporated, established or registered in such a country; or
  - b. A subsidiary of an entity incorporated, established or registered in such a country; or
  - c. An entity substantially controlled through entities incorporated, established or registered in such a country; or
  - d. An entity whose *beneficial owner* is situated in such a country; or
  - e. An Indian (or other) agent of such an entity; or
  - f. A natural person who is a citizen of such a country; or
  - g. A consortium or joint venture where any member of the consortium or joint venture falls under any of the above
5. The beneficial owner for the purpose of 4 above will be as under:
  - i. In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other means. Explanation—
    - a) "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent. of shares or capital or profits of the company;
    - b) "Control" shall include the right to appoint majority of the directors or to control the management or policy decisions including by virtue of their shareholding or management rights or shareholder agreements or voting agreements;
    - c) In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;
    - d) In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
    - e) Where no natural person is identified under (i) or (ii) or (iii) above, the beneficial owner is the relevant natural person who holds the position of senior managing official;
    - f) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
6. An "Agent" is a person employed to do any act for another, or to represent another in dealings with third person.
7. The successful bidder shall not be allowed to sub-contract works to any contractor from a country which shares a land border with India unless such contractor is registered with the Competent Authority. The definition of "contractor from a country which shares a land border with India" shall be as in paragraph 4 above.
8. A bidder is permitted to procure raw material, components, subassemblies etc. from the vendors from countries which share a land border with India. Such vendors will not be required to be registered with the Competent Authority as it is not regarded as "sub-contracting". However, in case a bidder has proposed to supply finished goods procured directly / indirectly from the vendors from the countries sharing land border with India, such vendor will be required to be registered with the Competent Authority.
