Reserve Bank of India is setting up an Adversarial Testing Facility and state-of-the-art Currency Research & Development Centre at Mysuru which will be undertaking research and development activities related to currency design and security features. The work for setting up the facilities has been assigned to Bharatiya Reserve Bank Note Mudran (P) Limited (BRBNMPL). This work has to be done in a time bound manner. The Foundation stone for CRDC has been laid on 22nd July 2022. To take this challenging job forward, BRBNMPL invites applications from Senior officers who have retired from the service of BRBNMPL as Dy. General Manager or above or have retired from the service of SPMCIL as Additional General Manager or above for the post outlined below:

- 1. Name of the Post offered: Advisor (One Position)
- 2. Equivalent to Grade: Deputy General Manager in BRBNMPL
- 3. Place of posting: Mysuru
- 4. Nature of posting: Contractual
- 5. Term: One year purely on temporary and contractual basis and, extendable further one year at a time, subject to satisfactory performance, up to two more years again on contractual basis at the discretion of the Company. The performance of the recruited retired officers will be periodically reviewed i.e. at half-yearly intervals and in case of unsatisfactory performance/conduct, BRBNMPL shall reserve the right to terminate the contract forthwith. BRBNMPL's decision in such matters shall be final and no further correspondence shall be entertained.
- 6. Job requirement in brief: The Advisor shall be mainly responsible for the following:
- i) She / he should have a positive and collaborative style that motivates and inspires performance and excellence;
- ii) To guide, train and monitor the team entrusted with development of designs of Bank Notes.;

- iii) Undertake work in co-ordination with BRBNMPL/RBI for setting up Adversarial Testing Facility and Currency Research Centre at Mysuru; to emulate adversaries and leverage the best offensive and defensive aspects of validation efficacy and counterfeit deterrence of banknotes and security features.
- iv) Coordinate with senior management team to evaluate the above projects efficiently
- v) Train and develop officers in the above functions
- vi) Additionally, providing support to Learning and Development Centre imparting expertise;
- vii) Any other job, that will be assigned by the Competent Authority as per organisational necessity.

7. Eligibility criteria-

A. General:

- i. The retired officer should not be more than 63 years of age on the date of declaration of vacancy through this notification.
- ii. The retired officer should have relevant work experience of not less than 3 years in handling the particular job for which she/ he is applying.
- iii. The retired officer should be having requisite expertise and must be meeting specific professional experience, if any, as specified by BRBNMPL against point 7B below.
- iv. The retired officer should be in reasonably good health to discharge her/his duties effectively.
- v. The retired officer should be willing to work at the place of posting for the entire duration of the contract.
- vi. The retired officer should not have any disciplinary proceedings pending against her / him in BRBNMPL / SPMCIL or in a court of law as on the date of applying.
- vii. The retired officer must either not be in another job in any capacity as on the date of applying or should furnish an employer's certificate to the effect that, if selected, she / he would be released to take up contractual employment with BRBNMPL within one calendar month of the date of the offer.
