- You may please ensure that you fulfill the eligibility criteria prescribed for the post <u>in all</u> <u>respects</u> as given in the Advertisement No.1/2021 before attending the interview. Please carry a government issued Photo ID (in Original) for verification.
- 2. Please bring with you printout of the registered application as explained at Para G of the Advt. No.1/2021 along with Original and photocopies of the following:
- (i) Date of Birth (SSLC certificate where the date of birth is recorded);
- (ii) Educational Qualification (SSLC marks card and certificate, Pre-university marks cards and certificate, Degree marks cards of all years / semesters, Degree certificate, marks cards and certificates of any other examination passed) in support of essential qualification and desirable qualifications. Please note that candidates having Full time First Class B.E./B.Tech/graduation degree in Engineering in Computer Science or Electronics & Communication or Information Technology from AICTE approved Institute / University will only be considered as having the <u>essential educational qualification</u>.
- (iii) Post-qualification Experience (Certificate on the letter head of employer) in support of essential experience and desired skills.
 - a) The experience certificates authenticated under employer's letter head should clearly indicate the length and line of experience and <u>must clearly indicate</u> that the candidate has at least five years of relevant experience in <u>Computer Networking including Network Security and/or Cyber/Information Security</u>.
 - b) Further, the certificates also should clearly satisfy the condition that the applicant has worked as a Network Administrator and/or Information Security Officer in a reputed company having Production or Manufacturing unit/PSU/Central or State Government/Consultancy firm empanelled by NICSI (National Informatics centre Services Inc.) during the period of experience submitted;
 - c) For verifying the <u>essential experience</u>, <u>post qualification experience</u> as mentioned above at para 2(iii) (a) and para 2(iii) (b), up to <u>October 01, 2021</u>, shall only be considered.
- (iv) Caste Certificate, if belonging to OBC Non-Creamy layer ((in the format prescribed for appointment to posts under Government of India – as per specimen displayed on the website). The OBC certificate containing the non-creamy clause should have been issued after 30.04.2021.
- (v) Other certificates, wherever applicable (SC / ST Certificate, Military Discharge Certificate, Disability Certificate issued by the appropriate authority indicating therein the nature and degree/ percentage of disability in the format prescribed for posts under Government of India);
- (vi) Candidates who have not passed the qualifying examination from Govt. Institutes / Universities should produce at the time of interview a suitable certificate to the effect that the Institute / University from where they have passed the course is duly recognised by the Government.

नै.का. बेंगलूरु CO, Bengaluru (vii) Applicants already in service of Government / Quasi Government Organisations, Public Sector Banks / Undertakings and Autonomous Bodies will have to keep a photocopy of the "No Objection Certificate" from their employer along with the printout of the application and submit the original for verification at the time of document verification before appearing for interview.

Candidates attending the interview without the Certificate/s as above and those who does not provide certificate in support of age, essential qualification (ref. above para 2(ii)) and essential experience (ref. above para 2(iii)) will not be allowed to appear for the interview, and their candidature is liable for cancellation. Please note that in case candidates have submitted photocopies of certificates in support of age, essential qualification and essential experience in advance to BRBNMPL, only original certificates are required to be submitted on the date of interview. However, eligibility of the candidates will be ascertained based on the original documents submitted on the date of interview.

- 3. a) If in the Engineering degree examination, which is the essential qualification, grades are awarded instead of marks, candidates should bring the numerical equivalent of the grade from the concerned University/Institute satisfying the condition that they have obtained First Class.
- b) Generally, the date as appearing in the relevant marks sheet of the qualifying examination will be taken as the date of passing the qualifying examination and post-qualification experience will be counted from the date of passing the last and final paper of the qualifying examination. If the date of passing the examination is not mentioned in the mark sheets **OR** if the date mentioned in the certificates is later than the date of passing the qualifying examination, candidates should bring the proof of date of passing the qualifying examination from the concerned University/ Institute for the purpose of computing the number of years of post-qualification experience.

The onus of proving eligibility in respect of qualification, percentage of marks obtained, age, post-qualification experience, caste status, percentage of disability, etc. as the case may be, lies on the candidate.

- 4. Candidates coming from outside the place of interview and <u>allowed to face the interview</u> after scrutiny of their applications will be reimbursed to and fro cost of 2-Tier AC railway fare / bus fare by the shortest route from the railway station/bus stand nearest to the place mentioned in the application or from the current place of posting within India from where they actually perform the journey for appearing at the interview, <u>subject to production of train/bus tickets</u>. Candidates have to <u>furnish their bank account details</u> while claiming reimbursement towards travel expenses.
- 5. Request for change of centre, date & time of interview will <u>NOT</u> be entertained. Failure to attend the interview on the date, time and place as stipulated above as also not bringing the original and photocopies of all mark cards / certificates / testimonials, etc. will lead to cancellation of your candidature.
