- Bidders are requested not to quote for the line items mentioned at S.No: 12, 13, 14 & 15 of Price Schedule. These line items may please be ignored. Bidders who have already submitted their bid may please resubmit the price-bid on MSTC portal. If any bidder quotes for the said line items, that particular amount **will not** be considered for calculation of Grand Total Amount and for finalization of L1.
- S.No: 12, 13, 14 & 15 of Price Schedule **will not** be considered for arriving at L1 bidder.
- Number of working days considered for calculation of wages is 26 days per month.
- Rates to be quoted by bidders for S.No. 1 to 4 of Price bid / Price Schedule should be as per Minimum wages applicable as per the revision of wages by Ministry of Labour & Employment, Govt. of India.

5. Contractor needs to ensure that the payments to deployed manpower is not less than the prevailing rates of Minimum Wages (as per Govt. of India Notifications, issued from time to time), as prescribed for the classification of work “Construction or Maintenance of Roads or Runways or in Building Operations including Laying Down Underground Electric, Wireless, Radio, Television, Telephone, Telegraph and Overseas Communication Cables and Similar other Underground Cabling Work, Electric lines, Water Supply Lines and Sewage Pipe Lines”. The present rate of Minimum wages for various categories of contract are as under

6. Bidders should consider above mentioned Minimum wages **only**. Those bidders who have **already submitted** their Price Schedule in MSTC as per old wages, may **resubmit** their Price schedule as per the latest revised wages (As mentioned in above table) on MSTC portal. Even if any bidder quotes as per old wages, latest wages will only be considered for Finalization of L1 bidder.
7. Rates to be quoted by bidders for S.No. 1 to 4 in Price bid / Price Schedule should be Minimum wages **including employer’s share of statutory payments Viz. ESI, EPF (Admin charges, EDLI)**.

Note: These changes are applicable to all other places of tender including Page No. (s) given above.

All other terms and conditions remain unchanged.
