Expression of Interest (EOI) is Cancelled							Testing of Samples carried out at two reputed laboratories. The test report and final evaluation report of the committee placed to the JPC for approval. Matter has been referred to RBI to take up in Strategic Planning Group(SPG) meeting. Subsequently , SPG in its meeting held on 10/05/22, has advised RBI to send proposal to Gol for floating Global Tender by seeking exemption.RBI has sent the proposal to Gol accordingly. As informed by MoF, we have requested MoF to authorized e-mail id of one of our official to submit online application in GTE portal (e-Samiksha). MoF authorized the same. Accordingly application for getting exemption for float GTE has been uploaded in GTE Portal (e-Samiksha). The application has been rejected by Ministry. we have intormed the same to RBI and sought their advise in this regard. Further the status was placed before SPG in its meeting held on September 26, 2023. As per decision taken in SPG meeting, BRBNMPL shall Re-Tender for the procurement of Over print Varnish. We have taken up with RBI for further advise.In reply, RBI informed that the matter related to re tendering for procurement of Over print varnish shall be reviewed after 3 Months depending on recommendation of technical group to carry out stage-wise lab and machine trial of Over print varnish developed by SPMCIL.
