In respect of bid for Services, the bidder must be the Service provider of the offered Service. 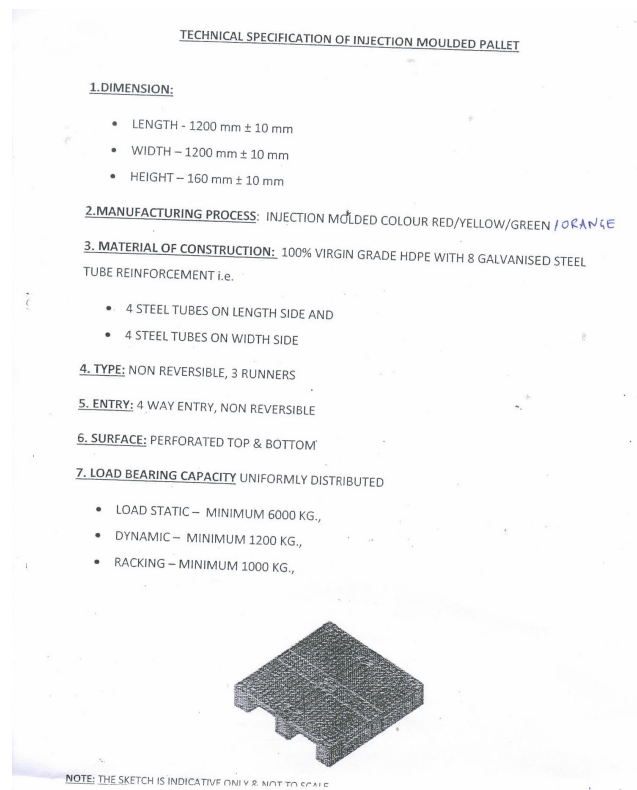
